President Fanucci led the Pledge of Allegiance.

President Fanucci asked if anyone from the public would like to comment. There was no public comment.

Assistant City Engineer David Maillet addressed proposed Resolution No. 2014-321, for the resurfacing of Landis Avenue. He explained that physical bump-outs are planned at intersections, there will be 2 mid-block crosswalks, bus stops will be revamped, and traffic lights are to be upgraded. The federal funding totals \$94,375. A new change order will be for \$46,000. The project construction is expected to begin in the Spring of 2015.

LSA Executive Director, Dennis Palmer, was invited to join with City Council as they discussed the planned shared services agreement. President Fanucci asked Mr. Gallo if Mayor Bermudez is expected. Mr. Gallo explained that the mayor indicated he would try to attend, but did not say for sure he would be here. City Council and Director Palmer reviewed the agreement, evaluating and discussing the comments and suggestions made by city staff. Mr. Gallo recorded the changes agreed to and will be formatting the agreement for further review by the LSA Commissioners and legal staff. President Fanucci expected the agreement to be effective as of September 1, 2014.

The Municipal Clerk reviewed the agenda.

City Council questioned Ordinance No's. 2014-34 and 2014-35, both amending Ordinance No. 8, and extending the salary range for the positions of Network Administrator 2, Supervisor, Information Technology Help Desk and Network Administrator 1. City Council members recalled that these positions were evaluated during the CY2014 budget review and denied increases by the governing body because the employees involved belong to negotiation units. It was noted that these employees have already been paid, so finance will have to work with payroll to recover the money already paid, without too much inconvenience to the employees. It was noted that the mayor was advised by Personnel, Business Administration and Finance that it was improper to grant raises outside the salary range approved by ordinance. Council members decided to leave these two ordinances on the agenda and members will vote accordingly.

The Municipal Clerk distributed copies of the annual audit report for the calendar year ended December 31, 2013. A resolution will be placed before City Council at the August 26 meeting verifying that City Council read, at minimum, the section involving "findings and recommendations."

City Council raised questions about several items that were removed from the agenda by Mayor Bermudez. First was the appointment of Public Safety Director Edwin Alicea. President Fanucci asked Mrs. Monaco to find out if the mayor wishes to withdraw his appointment. If the mayor still wants Mr. Alicea, the appointment letter and the corresponding resolution will be added to the agenda for consideration on Tuesday, August 12.

Council directed the Clerk to add the resolution to the agenda regarding the public relations contract with Lee Tofanelli & Associates. This is an item removed by Mayor Bermudez.

Council directed the Clerk to add the ordinance updating the qualifications for the Business Administrator to the agenda. This is an item removed by Mayor Bermudez.

Council directed the Clerk to add the ordinance prohibiting department directors from earning overtime or compensatory time to the agenda. This is an item removed by Mayor Bermudez.

Council directed the Clerk to add the resolution confirming the removal of William Lutz from the position of Business Administrator. Mr. Lutz, through his attorney, was invited to participate in an interview a second time, since he chose not to appear the first time. The second invitation was also rejected by Mr. Lutz's attorney. Council members commented about their frustration about a lack of response from the mayor. Councilman Procopio recommended that the mayor provide a reason when he removes any item from the agenda. Councilman Procopio will also attempt to contact Mayor Bermudez, since efforts by President Fanucci and Vice President Spinelli have not produced return calls.

Councilwoman Calakos reported on a continuing issue with Mrs. Jost at 75 Evelyn Avenue and her neighbors who now want to paint a fence pink. This matter will be forwarded to Licenses & Inspections for assistance.

Councilwoman Gonzalez reported that the youth football camp is on Saturday, August 9 at Gittone Stadium from 9 a.m. until 1 p.m.

Councilman Spinelli reported that the move-in has started at the new PAL building on Sixth Street. An opening is planned in a few weeks. He also reported that the VDID will be meeting on Thursday morning with the intent to hire a new director to replace Gary Holloway, who is leaving the post.

President Fanucci introduced NJ Senator Jeff Van Drew, who asked to make comments at tonight's meeting. Senator Van Drew explained that the West Campus of the Vineland Developmental Center on Almond Road was closed a few years ago. The property is owned by the State of New Jersey and comprises approximately 69 acres, with about 15 buildings on it. Currently a preschool facility is the only thing operating there. Senator Van Drew introduced Rabbi Shlomo C. Kanarek, who is proposing to make the property a rabbinical college. Rabbi Kanarek is a resident of Lakewood and is involved in other businesses, including an ethanol production facility in Bridgeton and an auto parts manufacturing concern. The Rabbi explained that rabbinical students now travel to Israel, which is a dangerous place to be right now. President Fanucci said City Council would welcome further dialogue about the proposed project.

Councilman Procopio thanked Seth Velez, Senator Van Drew and Rabbi Kanarek for attending tonight. He also presented a Rolls Royce magazine that features Vineland, describing the equipment provided for the electric utility.

Councilwoman Gonzalez thanked Seth Velez for wanting to be involved. She noted that many young people from Vineland are getting involved in community matters.

Councilwoman Calakos noted the recent ribbon cutting ceremony for the Vineland Urgent Care facility on Lincoln Avenue. She congratulated former Councilwoman Sheena Santiago and her son Robin for opening a new store on Delsea Drive. She also noted the upcoming 150th Anniversary Gala celebrating the Vineland Historical & Antiquarian Society on December 6 at the Greenview Inn.

Councilman Spinelli reiterated the grand opening of the new PAL building on Saturday. He invited all to attend the Vineland Downtown Improvement District Taste of Vineland event on October 15 at the Greenview Inn. Tickets are \$30 per person. The VDID holiday parade is being planned. He also reported that fall recreation activities are going strong.
