## ORDINANCE NO. 2014<u>-47</u>

AN ORDINANCE PROVIDING FOR NO PARKING RESTRICTIONS ALONG A PORTION OF FREDERICK COURT.

WHEREAS, the City Engineer's Office has recommended that parking be prohibited along a portion of Frederick Court; and

WHEREAS, said recommendation has the concurrence of the Vineland Police Department and the City Solicitor and is considered to be in the best interest of the City of Vineland; now, therefore,

## BE IT ORDAINED BY THE COUNCIL OF THE CITY OF VINELAND THAT:

**SECTION 1**. No person shall park a vehicle at any time upon any of the following described streets or parts of streets:

Name of Street	Location
Frederick Court	Beginning at the intersection of the southerly curbline of Frederick Court with the westerly curbline of Golda Lane; thence
Frederick Court	Along the southerly curbline in a westerly direction a distance of 700.00 feet; thence
Frederick Court	Along the curbline in a northwesterly direction along an arc distance of 200.00 feet to the westerly edge of a Driveway on lot 15, block 5201.

**SECTION 2**. Signs shall be erected and maintained as authorized by the Commissioner of Transportation of the State of New Jersey.

**SECTION 3.** All ordinances or parts thereof inconsistent with the provisions of this ordinance are hereby repealed to the extent of such inconsistency.

**SECTION 4.** This Ordinance shall take effect upon passage and publication as provided by law.

Denise,

A resident approached our staff with concerns for the ability of emergency vehicles to traverse the roadway when the street has parking on both curblines. Upon consideration, our office determined that a parking prohibition was in order.

The figure below indicates the prohibited parking area in red. This is the southerly side and around the bulb of the cul-de-sac. The southerly side was chosen because there are fewer driveways and, more importantly, there is a fire hydrant on that side, which is a statutory no parking zone.
