A RESOLUTION AUTHORIZING THE ISSUANCE OF AN OPEN-END CONTRACT TO OCEANPORT, LLC, CLAYMONT, DE FOR PROVIDING AND DELIVERING ROCK SALT THROUGH THE CUMBERLAND COUNTY COOPERATIVE PRICING SYSTEM.

WHEREAS, the City of Vineland is a participant in the Cumberland County Cooperative Pricing System, pursuant to Resolution No. 96-534, adopted August 13, 1996; and

WHEREAS, the County of Cumberland, as the Lead Agency, has advertised for bids and received bids on behalf of all participating contracting units in the Cooperative Pricing System for Providing and Delivering Rock Salt; and

WHEREAS, the County of Cumberland has reviewed said bids and has made an award to the lowest responsive, responsible bidder, Oceanport, LLC, Claymont, DE, based upon the unit price of \$87.50/ton (no beige tint) for the quantity range of 0 to 1000 tons, for the contract period from date of award through October 31, 2015, with option to extend for two (2) one (1) year periods as conditioned in N.J.S.A. 40A:11-15 and upon mutual agreement of the parties; and

WHEREAS, the City of Vineland desires to enter into an agreement with Oceanport, LLC for Providing and Delivering Rock Salt under the cooperative pricing system contract awarded by the County of Cumberland, based upon the unit prices of \$87.50/ton (no beige tint) for the quantity range of 0 to 1000 tons, for the contract period from date of award through October 31, 2015, with option to extend for two (2) one (1) year periods as conditioned in N.J.S.A. 40A:11-15 and upon mutual agreement of the parties; and

WHEREAS, the City Comptroller has certified the availability of funds for the contract to be awarded herein;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF VINELAND, as follows:

1. THAT the Mayor and City Clerk are hereby authorized to execute an agreement with Oceanport, LLC, Claymont, DE for Providing and Delivering Rock Salt, based upon the unit price of \$87.50/ton (no beige tint) for the quantity range of 0 to 1000 tons, for the contract period from date of award through October 31, 2015, with option to extend for two (2) one (1) year periods as conditioned in N.J.S.A. 40A:11-15 and upon mutual agreement of the parties based upon the open-end contract awarded by the County of Cumberland cooperative pricing system.

2. THAT the Purchasing Agent be and the same is hereby authorized and directed to issue a purchase order contract to Oceanport, LLC for Providing and Delivering Rock Salt, as stated above.

WHEREAS, this Board duly received and opened bids for providing and delivering rock salt for the County of Cumberland and to participating members of the Cumberland County Cooperative Contract Pricing System Identifier #181-CCCCPS; and

NOTE: Chemical Equipment Labs submitted the lowest bid, however they had an exception to the bid specifications that was reviewed by the Director of the using department and was found to be unacceptable. The specifications stated "not more than .5 percent moisture" but Chemical Equipment's bid indicated "moisture content will not exceed three percent (3%).

WHEREAS, the Director of Purchasing has reported that Cargill, Inc. - Deicing Technology Business Unit, 24950 Country Club Blvd., Suite #450, North Olmsted, OH 44070 (Item #1-No Beige Tint and Item #2-Beige Tint) was the lowest responsive, responsible bidder.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF CHOSEN FREEHOLDERS OF THE COUNTY OF CUMBERLAND, as follows:

1. That this Board hereby recommends an open-ended contract be awarded to Cargill, Inc.-Deicing Technology Business Unit in accordance with the specifications and the bid of the contractor for the contract period November 1, 2014 through October 31, 2015 contingent upon appropriation of sufficient funds in the temporary and/or permanent 2015 Budget and the County shall have the option to extend for two (2) one (1) year periods as conditioned in N.J.S.A. 40A:11-15 and upon mutual agreement of the parties.

2. ~~That, additionally, Oceanport, L.L.C., P.O. Box 608, Claymont, DE 19703-0608 (Item 1 & 2) shall be declared the winning bidder for the Cumberland County Cooperative Contract Purchasing System Identifier #181-CCCCPS. Cargill, Inc. did not agree to provide to the Cooperatives.~~

3. That the proper officers of this Board are hereby authorized and directed to execute the contract hereby awarded.

4. That the proper account numbers will be charged and funds encumbered prior to services being provided.
