WHEREAS, the City Engineer's Office has recommended that parking be prohibited along the entire limits of Valley Avenue; and

WHEREAS, said recommendation has the concurrence of the Vineland Police Department and the City Solicitor and is considered to be in the best interest of the City of Vineland; now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF VINELAND THAT:

SECTION 1. No person shall park a vehicle at any time upon any of the following described streets or parts of streets:

		to the northerly curbline of Walnut Road

- **SECTION 2**. Signs shall be erected and maintained as authorized by the Commissioner of Transportation of the State of New Jersey.
- **SECTION 3.** All ordinances or parts thereof inconsistent with the provisions of this ordinance are hereby repealed to the extent of such inconsistency.
- **SECTION 4.** This Ordinance shall take effect upon passage and publication as provided by law.


