A RESOLUTION AUTHORIZING THE ISSUANCE OF AN OPEN-ENDED CONTRACT TO SOUTH STATE, INC., BRIDGETON, NJ FOR SUPPLYING AND LAYING HOT MIX ASPHALT THROUGH THE CUMBERLAND COUNTY COOPERATIVE PRICING SYSTEM.

WHEREAS, the City of Vineland is a participant in the Cumberland County Cooperative Pricing System, pursuant to Resolution No. 96-534, adopted August 13, 1996; and

WHEREAS, the County of Cumberland, as the Lead Agency, has advertised for bids and received bids on behalf of all participating contracting units in the Cooperative Pricing System for Supplying and Laying Hot Mix Asphalt; and

WHEREAS, the County of Cumberland has reviewed said bids and has made an award to the lowest responsive, responsible bidder, South State, Inc., Bridgeton, NJ, for the contract period September 1, 2015 through August 31, 2016, based on the quoted price as follows:

WHEREAS, the City of Vineland desires to enter into an agreement with South State, Inc., for Supplying and Laying Hot Mix Asphalt under the cooperative pricing system contract awarded by the County of Cumberland for the contract period September 1, 2015 through August 31, 2016, in an amount based upon the quoted price, as stated above; and

WHEREAS, the City Comptroller has certified the availability of funds for the contract to be awarded herein;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF VINELAND, as follows:

1. THAT the Mayor and City Clerk are hereby authorized to execute an agreement with South State, Inc., for the Supplying and Laying Hot Mix Asphalt for the contract period September 1, 2015 through August 31, 2016, based upon the open-ended contract awarded by the County of Cumberland cooperative pricing system.

2. THAT the Purchasing Agent be and the same is hereby authorized and directed to issue a purchase order contract to South State, Inc., for Supplying and Laying Hot Mix Asphalt, as stated above.

**RESOLUTION AWARDING AN OPEN-ENDED CONTRACT FOR  
SUPPLYING AND LAYING HOT MIX ASPHALT FOR THE  
CUMBERLAND COUNTY PUBLIC WORKS DEPARTMENT AND THE  
CUMBERLAND COUNTY COOPERATIVE CONTRACT PURCHASING

WHEREAS, this Board duly received and opened bids for supplying and laying hot mix asphalt for the Cumberland County Public Works Department and the Cumberland County Cooperative Contract Purchasing System Identifier #181-CCCCPS; and

1. That this Board hereby recommends an open-ended contract be awarded to South State, Inc. in accordance with the specifications and the bid of the contractor in the amount of \$58.00/ton for pick-up; \$98.00/ton for supply/lay and \$7.00/sy for milling for the contract period September 1, 2015 through August 31, 2016 and said contract shall be contingent upon appropriation of sufficient funds in the temporary and/or permanent 2015 and 2016 Budgets.

2. That, additionally, South State, Inc. shall be declared the winning bidder for the

Cumberland County Cooperative Contract Purchasing System Identifier #181-CCCCPS.

3. That the proper officers of this Board are hereby authorized and directed to execute the contract hereby awarded.

4. That the proper account numbers will be charged and funds encumbered prior to services being provided.
