RESOLUTION ACCEPTING THE NON VULT PLEA OF RONNICK INC., T/A COSMOPOLITAN RESTAURANT, LOUNGE, BAKERY, THE HOLDER OF PLENARY RETAIL CONSUMPTION LICENSE NO. 0614-33-007-010, RELATING TO CHARGES ON OR ABOUT OCTOBER 4, 2014, NOVEMBER 27, 2014, DECEMBER 18, 2014 AND MAY 14, 2015

WHEREAS, charges have heretofore been duly served upon the named licensee charging that on or about October 4, 2014, November 27, 2014, December 18, 2014 and May 14, 2015, the licensee allowed, permitted and/or suffered on or about the licensed premises: (1) a brawl or act of violence (4 counts); (2) conduct in such a manner as to become a nuisance adversely affecting the quality of life of the City of Vineland (5 counts); (3) conduct in such a manner as to require police intervention or adversely affecting public safety or rights of the public (5 counts); (4) sold or delivered alcoholic beverages before or after the legal notice of sales set forth in the Code of the City of Vineland; (5) the presence of non-employees on the licensed premises before or after the legal hours of sale as set forth in the Code of the City of Vineland; (6) the sale, service and delivery of alcoholic beverages or permit the consumption of alcohol beverages on the licensed premises between 2:00 a.m. and 12:00 noon; and

WHEREAS, a plea of Non Vult was executed and delivered to the City Clerk by the legal representative of the license holder dated October 19, 2015; and

WHEREAS, Council for the license holder has waived their right to a hearing on all charges and has accepted, subject to determination of the City Council, a suspension of ten (10) days effective November 25, 2015, through December 4, 2015; and

WHEREAS, City Council has determined that this licensee will transfer their license, person to person, and will no longer have any ownership interest thereto and further that the licensee has not been charged with any other violations in the immediate past.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Vineland that Plenary Retail Consumption License No. 0614-33-007-010 heretofore issued by the City of Vineland to Ronnick, Inc., t/a Cosmopolitan Restaurant, Lounge, Bakery for premises located at 3515 S. Delsea Drive, Vineland, New Jersey, be and is hereby suspended for a period of ten (10) consecutive days, effective November 25, 2015, through December 4, 2015, inclusive.

BE IT FURTHER RESOLVED that the Council of the City of Vineland does not object to the licensee paying a fine in lieu of suspension, if said licensee makes application to the Director of the New Jersey Division of Alcoholic Beverage Control.
