WHEREAS, the Assistant Business Administrator has, under date of February 2, 2016 submitted a written report and tabulation of the bids received and has recommended that a contract for the furnishing and delivery of a 30 kW Generator for the Department of Public Works, be awarded to Warshauer Generator LLC., Tinton Falls, NJ in the amount of \$20,155.56, said bid being the only bid received and considered in the best interest of the City of Vineland; now, therefore,

BE IT RESOLVED by the Council of the City of Vineland that said contract for the furnishing and delivery of a 30 kW Generator for the Department of Public Works, be and the same is awarded to Warshauer Generator LLC., Tinton Falls, NJ on their bid in the amount of \$20,155.56, said bid being the only bid received and considered in the best interest of the City of Vineland, and the Purchasing Agent be and the same is hereby authorized and directed to issue purchase order contract for the same in behalf of the City; and
