A RESOLUTION AWARDED AN OPEN-END CONTRACT TO MONARCH BOILER CONST. CO., INC., BLACKWOOD, NJ, FOR PRESSURE PIPING, FABRICATION & INSTALL PROJECTS FOR THE VINELAND MUNICIPAL ELECTRIC UTILITY – GENERATION DIVISION, IN THE AMOUNT OF \$61,665.00.

WHEREAS, the City of Vineland has heretofore advertised for bids for Pressure Piping, Fabrication & Install Projects for the Vineland Municipal Electric Utility – Generation Division, for the period of one year beginning August 1, 2016, with option for a second year, in accordance with specifications on file in the office of the Purchasing Agent; and

WHEREAS, on June 14, 2016, bids were received, duly opened and read aloud, being referred to the Business Administrator for tabulation, evaluation, report and recommendation; and

WHEREAS, the Business Administrator has, under date of July 5, 2016, submitted a written report and tabulation of the bids received and has recommended that an open-end contract for Pressure Piping, Fabrication & Install Projects for the Vineland Municipal Electric Utility – Generation Division, be awarded to Monarch Boiler Const. Co., Inc., Blackwood, NJ, in the amount of \$61,665.00, said bid being the lowest bid received and considered in the best interest of the City of Vineland; now, therefore,

BE IT RESOLVED by the Council of the City of Vineland that said open-end contract for Pressure Piping, Fabrication & Install Projects for the Vineland Municipal Electric Utility – Generation Division, for the period of one year beginning August 1, 2016, with option for a second year, be and the same is awarded to Monarch Boiler Const. Co., Inc., Blackwood, NJ, on their bid in the amount of \$61,665.00, said bid being the lowest bid received and considered in the best interest of the City of Vineland, and the Purchasing Agent be and the same is hereby authorized and directed to issue purchase order contract for the same in behalf of the City; and

BE IT FURTHER RESOLVED that the City Comptroller has certified that the funds for the contract to be awarded herein are available.


