A RESOLUTION AUTHORIZING THE SALE OF SCRAP ALUMINUM WIRE AND COPPER WIRE, FROM THE VINELAND MUNICIPAL UTILITIES – DISTRIBUTION DIVISION, NOT NEEDED FOR PUBLIC USE AND AUTHORIZING THE EXECUTION OF AN AGREEMENT OF SALE.

WHEREAS, pursuant to N.J.S.A. 40A:11-36, any contracting unit by resolution of its governing body may authorize the sale of its personal property not needed for public use; and WHEREAS, the City of Vineland advertised for quotations for the Sale of Scrap Aluminum Wire, Copper Wire & Mixed Metals from the Vineland Municipal Utilities – Distribution Division; and

WHEREAS, on November 10, 2016, one quotation was received by the Purchasing Board and reviewed by Management Personnel of the Municipal Electric Utility; and

WHEREAS, it is recommended that it is in the best interest of the City of Vineland to accept the only quote received for **Aluminum Wire and Copper Wire only**, as follows:

- 2. THAT Buyers agrees to:

- Provide certified weight of empty vehicle they will be using to remove the scrap. Certified weight slips must show vehicle tag number and description of the scrap clearly indicated on weight slip. Buyer to have scrap weighed at a local certified scale, (NOT THEIR OWN) accompanied by a city employee. All costs associated with weighing, will be paid by buyer. Payment to the City will be on the actual weight (lbs) of the scrap, verified by the weight slips, at the price submitted per pound.
- All scrap shall be removed within ten (10) business days of notification of award. The City must be given 24-hour notice prior to removal. Weight slips are to be given to the City of Vineland Purchasing Division. Weights will be verified and an invoice will be sent to the buyer with the amount to be paid the City.
- Loading and removal is the sole responsibility of the buyer. The City of Vineland will be available to <u>aid</u> in the loading of the scrap.
- Payment: Cash or check (check payable to the City of Vineland) to be delivered to the Purchasing Division within seven days of receipt of invoice.
- 3. THAT the Purchasing Agent, upon receipt of payment is hereby authorized and directed to release said items as stated above.
