ORDINANCE NO. 2017-71

ORDINANCE AMENDING ORDINANCE 97-87, AS AMENDED, CHAPTER 135, SECTION 135-11 OF THE CODE OF THE CITY OF VINELAND ENTITLED SUBDIVISION OF EQUIPMENT MAINTENANCE AND VEHICLE FUELING FACILITY;, SECTION 135-12 OF THE CODE OF THE CITY OF VINELAND ENTITLED DIVISION OF ENGINEERING AND SECTION 135-13 ENTITLED SUBDIVISION OF PLANNING

WHEREAS, within Chapter 135 entitled Public Works, Department of, is section 135-11 entitled Subdivision of Equipment Maintenance and Vehicle Fueling Facility; and

WHEREAS, the said subdivision encompasses services provided to all departments within the City of Vineland and therefore it is recommended by the Business Administrator that said subdivision should be removed from the Department of Public Works and placed within the Department of Administration so as to alleviate the Department of Public Works from the responsibility of equipment maintenance and vehicle fueling for all of the departments within the City of Vineland; and

WHEREAS, within Chapter 135 entitled Public Works, Department of, is section 135-12 entitled Division of Engineering; and

WHEREAS, the Division of Engineering is responsible for providing needed services to all departments within the City of Vineland and therefore it is recommended by the Business Administrator that said division should be removed from the Department of Public Works and placed within the Department of Administration so as to alleviate the Department of Public Works from the responsibility of engineering services for all of the departments within the City of Vineland; and

WHEREAS, within Chapter 135 entitled Public Works, Department of, is section 135-13 entitled Subdivision of Planning; and

WHEREAS, the Subdivision of Planning works closely with the Division of Engineering and therefore is recommended by the Business Administrator that said division should be removed from the Department of Public Works and placed within the Department of Administration to coincide with the placement of the Division of Engineering within the Department of Administration.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Vineland as follows:

1. Chapter 135, Section 135-11 shall be deleted in its entirety.
2. Chapter 135, Section 135-12, shall be deleted in its entirety.
3. Chapter 135, Section 135-13 shall be deleted in its entirety.

BE IT FURTHER ORDAINED that any Ordinance or portions thereof that are inconsistent herewith shall be deleted and void to the extent of such inconsistencies and the terms of this Ordinance shall supersede the same.

This Ordinance shall take effect upon adoption and publication according to Law.
