

RESOLUTION NO. 2013- 323

A RESOLUTION PROVIDING FOR THE INSERTION IN THE CALENDAR YEAR 2013 BUDGET OF THE CITY OF VINELAND A SPECIAL ITEM OF REVENUE MADE AVAILABLE BY REVENUE REALIZED FROM A VINELAND POLICE ATHLETIC LEAGUE, SUMMER CAMP PROGRAM GRANT, IN THE AMOUNT OF \$5,440.00 AND AN APPROPRIATION IN SAID BUDGET FOR LIKE SUM AND PURPOSE

WHEREAS, N.J.S. 40A:4-87 provides that the Director of the Division of Local Government Services may approve the insertion of any special item of revenue in the budget of any county or municipality when such item shall have been made available by law and the amount thereof was not determined at the time of the adoption of the budget; and

WHEREAS, said Director may also approve the insertion of an item of appropriation for equal amount;

NOW, THEREFORE, BE IT RESOLVED, as follows:

SECTION 1. THAT the Council of the City of Vineland hereby requests the Director of the Division of Local Government Services to approve the insertion of an item of revenue in the budget of the Calendar Year 2013 in the sum of.....\$5,440.00

which item is now available as a revenue from an increase Vineland Police Athletic League, Summer Camp Program Grant, pursuant to the provisions of statute;

SECTION 2. THAT a like sum of\$5,440.00

be and the same is hereby appropriated under the caption of;

Vineland Police Athletic League Summer Camp Program Grant

SECTION 3. THAT the above is the result of a Vineland Police Athletic League, Summer Camp Grant and the need of appropriation to be used to defray the cost of same as herein recited.


