President Fanucci asked if anyone from the public would like to comment.

Douglas Albrecht, Vineland, NJ, voiced concerns over Apple Farms pulling out of the management of the Landis Theater. He urged Council to work on this matter stating the project would cost the City 10 million dollars if it closes. He questioned Council on the Improvement Authority which have bonds in place for Economic Development and feels Vineland does not get their fair share. He stated Vineland pays the Improvement Authority for trash pick-up and recycling. He expressed concern over the Landis Sewerage Authority revaluation of properties that is going to be taking place. He explained any raise in fees and taxes hurts the tax payers and business owners. He urged Council to not raise any taxes and help struggling businesses.

There being no other comments to be heard, the Deputy Clerk reviewed the agenda.

Supervising Planner Kathleen Hicks was present to show support for Ordinance No. 2013-40, amending Ordinance 2004-25, as amended, entitled an ordinance adopting the Center City redevelopment plan consistent with resolution 6050 of the Planning Board of the City of Vineland regarding the Main Street District outdoor dining and seating design standards. Councilman Spinelli asked if Planning had concerns regarding this ordinance and restaurants cooking outside. Supervising Planner Hicks stated she had no objection to the plans for the project however other departments may have issues that need to be discussed. She believes any outside cooking would be handled through the Health Department. Councilman Spinelli asked for regulations to be in place for outside grilling and cooking.

SNAP Director Alex Curio and Supervising Planner Kathleen Hicks were present to discuss Ordinance No. 2013-41, amending Ordinance 86-38, chapter 425, of the City of Vineland to revise article VII, affordable housing and article XV, zoning consistent with resolution 6051 of the Planning Board of the City of Vineland. They explained the change to the Ordinance is to comply with the State COAH laws. SNAP Director Curio stated the City is not being treated fairly when it comes to affordable housing or the fees. He stated there are three options for the collection of COAH obligation funding, option one there is no obligation on the developer for the funds; option two the developer is responsible for paying one and half percent of the equalized assessed value of the finished project to the City for residential properties and two and half percent for businesses; option three the developer pays a per unit charge. SNAP Director Curio explained the fees collected get deposited into the affordable housing fund to be used for rehabbing homes in the City. The rehab funds can only be for necessary repairs to the home no luxury items. The City currently follows HUD strict rules for allowances of rehabbing. President Fanucci questioned the regulations and fees. President Fanucci wanted to know if these regulations can only be for new development not existing development or developers. Supervising Planner Hicks stated she has been discussing these changes with developers and they are happy to pay the one and half percent. President Fanucci asked for more correspondence with developers and stated more discussion is needed for this issue and asked to have the ordinance removed from the agenda.

Councilwoman Gonzalez asked if the cameras that are placed on the streets are able to take pictures of license plates for any traffic violations. Assistant Business Administrator Monaco stated the cameras are not set up for taking pictures they are monitored and watched but do not record.

Director of Finance, Roxanne Tosto and Tax Collector, Carmen DiGiorgio narrated a slide presentation to explain the tax rate and the tax bill. The slides illustrated how the tax rate is derived and components of the tax bill.

Lee Burke referenced the Landis Sewerage Authority legal services resolution and he suggested the city and the LSA meet to discuss the finances and software differences the two entities have. He also suggested that a group of citizens be invited to review the facts.

Sam Fiocchi spoke against the proposed relocation of the Social Services facility to Bridgeton. He said the move would have a detrimental impact on economic development and create a hardship for Vineland residents who utilize the service. He claimed it was a poor political decision.

Frank Guaracini, Jr. applauded City Council for entertaining the resolution opposing the relocation of the Social Services program. He cited recent activity, noting the former ShopRite building's current vacant status, and expressed concern about the loss of 250 jobs from Vineland. He also noted the substantial costs involved to move the facility.

Bill Gonzalez commented that the Cumberland County Freeholders recently raised taxes by 3%. He said we all must stay vigilant on the proposed relocation of the Social Services program.

Jim Sauro also opposes the relocation of the Social Services program.

Bob Greco demonstrated a stack of minutes from the Board of Social Services and reported that the proposed move of the program was not discussed once by the board over the past year.

Albert Kelly, Mayor of Bridgeton, complimented the city's recognition of the police chaplain program. Regarding the proposed relocation of the Social Services program, he claimed that 54% of the program clients come from the western and southern part of the County.

Diamaris Rios, an employee of the County Social Services encouraged people to attend the Freeholders' meeting to express their opinion.
