WHEREAS, the Business Administrator has, under date of March 20, 2018 submitted a written report and tabulation of the bids received and has recommended that a contract for the Resurfacing of Panther Road (Rita Avenue to Dante Avenue), be awarded to South State, Inc., Bridgeton, NJ, in the amount of \$659,889.19, said bid being the lowest bid received and considered in the best interest of the City of Vineland; now, therefore,

BE IT RESOLVED by the Council of the City of Vineland that said contract for the Resurfacing of Panther Road (Rita Avenue to Dante Avenue), be and the same is awarded to South State, Inc., Bridgeton, NJ, on their bid in the amount of \$659,889.19, said bid being the lowest bid received and considered in the best interest of the City of Vineland, and the Purchasing Agent be and the same is hereby authorized and directed to issue purchase order contract for the same in behalf of the City; and

BE IT FURTHER RESOLVED that the Chief Financial Officer has certified that the funds for the contract to be awarded herein are available.
