BE IT RESOLVED by the Council of the City of Vineland that said contract for the furnishing and delivery of 15KV URD Cable for the Vineland Municipal Electric Utility, be and the same is awarded to Wesco Distribution, Richmond, VA, in the amount of \$62,326.63, plus a contingency in the amount of \$3,066.33 to allow for manufacturer's standard length put-up tolerances of +/-10%, said bid being the lowest bid received and considered in the best interest of the City of Vineland, and the Purchasing Agent be and the same is hereby authorized and directed to issue purchase order contracts for the same in behalf of the City; and

BE IT FURTHER RESOLVED that the City Comptroller has certified that the funds for the contracts to be awarded herein are available.

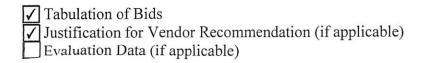

Evaluation

 American Wire & Cable for item #238-003 – This original "total cost" seemed unusually low. On requesting clarification of details, they originally quoted this item as only one reel of wire as 5,001 linear feet (for one reel of wire), not 5,001 circuit feet for three reels of wire. We are looking to purchase 5,001 circuit feet (15,003 linear feet) of cable. They indicated a willingness and ability to provide the original requested footage at the same per unit cost of \$8,400 per 1,000 feet of 3 phase cable.

The cost for this item is now, \$42,008.40 for 5,001 circuit feet of cable (1,667circuit feet per reel X 3 reels).

Recommendation

The apparent low Bidder is Wesco Distribution, for cable manufactured by CME for items 238-001 and 238-003.

Please allow a 5% contingency on all items to allow for manufacturer's standard length put-up tolerances of +/- 10%. Do **NOT** show this amount on copy to successful Bidder's copy.
