A RESOLUTION AUTHORIZING THE EXECUTION OF PROFESSIONAL SERVICES AGREEMENTS WITH QUALIFIED VENDORS ON AN AS-NEEDED BASIS FOR GENERAL ENVIRONMENTAL CONSULTING AND ENGINEERING SERVICES FOR THE CITY OF VINELAND

WHEREAS, the City of Vineland has heretofore advertised for proposals for Professional Services for general environmental consulting and engineering services concerning matters for the City of Vineland in accordance with RFQ 2018-09; and

WHEREAS, the Requests were published in the City's official newspaper and the City's website in accordance with N.J.S.A. 19:44A-20.4 et seq.; and

WHEREAS, nine (9) sealed proposals were received from the professionals listed on Schedule A attached hereto and made a part hereof, referred to the Business Administrator and Qualified Purchasing Agent and on February 16, 2018 were read to qualify professionals to provide as-needed price quotations for the provision of the aforesaid services in accordance with N.J.S.A. 19:44A-20.4 et seq.; and

WHEREAS, the professionals listed on Schedule A have been qualified to provide the services of the type and nature to carry out the aforesaid services: and

WHEREAS, it has been recommended that a contract for the required services be awarded to those professionals listed on Schedule A based upon and in accordance with the proposals submitted and received pursuant to a fair and open process; and

WHEREAS, professional services agreements shall be issued to the professionals listed on Schedule A for a contract period of February 1, 2018 through January 31, 2019; and

WHEREAS, no funds shall be encumbered until such time as the services are ordered and the availability of funds for said Professional Services Contract to be awarded herein have been certified by the Chief Financial Officer and the purchase order shall encumber appropriate account numbers as determined by the Chief Financial Officer at the time the purchase order is created in; and

WHEREAS, the Local Public Contracts Laws require the Resolution and Professional Services Agreement be available for public inspection in the Office of the City Clerk.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Vineland that said contract for Professional Services for Environmental Consulting and Engineering Services, be awarded to those professionals listed on Schedule A on an as-needed basis based upon the proposal received, pursuant to a fair and open process, and the Mayor and Clerk are authorized to execute a Professional Services Agreement in accordance with this Resolution for a contract period of February 1, 2018 through January 31, 2019.
