RESOLUTION AUTHORIZING A CONTRACT AWARD TO A STATE CONTRACT VENDOR, SHI INTERNATIONAL CORP., SOMERSET, NEW JERSEY, FOR THE PURCHASE OF RUBRIK DATA BACKUP AND RECOVERY HARDWARE/SOFTWARE MAINTENANCE RENEWAL.
