A RESOLUTION AWARDING A NEGOTIATED OPEN-END CONTRACT TO CRAFT OIL CORPORATION d/b/a PETROCHOICE HOLDINGS, AVOCA, PA, FOR THE FURNISHING AND DELIVERY OF TRENT 60 LUBRICATING OIL AND COOLANT FOR THE VINELAND MUNICIPAL ELECTRIC UTILITY – GENERATION DIVISION, IN THE AMOUNT OF \$50,832.18.

WHEREAS, on October 23, 2018, the City Council of the City of Vineland adopted Resolution No. 2018-406, entitled "A RESOLUTION AWARDING AN OPEN-END CONTRACT TO SPENERGY LLC, ALPHARETTA, GA, FOR THE FURNISHING AND DELIVERY OF TRENT 60 LUBRICATING OIL AND COOLANT FOR THE VINELAND MUNICIPAL ELECTRIC UTILITY – GENERATION DIVISION, IN THE AMOUNT OF \$57,486.00; and

WHEREAS, on November 13, 2018, City Council adopted Resolution No. 2018-452 rescinding Resolution No. 2018-406 and authorizing the Purchasing Agent to negotiate a new contract because of Spenergy's notification to the City that the company was no longer an authorized Mobile Products Dealer, a specification requirement; and

WHEREAS, the Purchasing Agent contacted Craft Oil Corporation d/b/a PetroChoice Holdings, a Mobile Dealer and previous supplier of the required products to the City; and

WHEREAS, at the request of the Purchasing Agent, Craft provided their Best and Final Offer, which has been reviewed by the Purchasing Agent, the Director of Municipal Utilities and other Electric Utility personnel; and

WHEREAS, the Purchasing Agent has, under date of November 26, 2018 submitted a summary of said negotiations and it is recommended that an open-end contract for the Furnishing and Delivery of Trent 60 Lubricating Oil and Coolant for the Vineland Municipal Electric Utility – Generation Division, be awarded to Craft Oil Corporation d/b/a PetroChoice Holdings, Avoca, PA, for the contract period of January 1, 2019 through December 31, 2019, in the amount of \$50,832.18; now, therefore,

BE IT RESOLVED by the Council of the City of Vineland that (by the affirmative vote of two-thirds of the full membership of the governing body of the City of Vineland) that said negotiated open-end contract for the Furnishing and Delivery of Trent 60 Lubricating Oil and Coolant for the Vineland Municipal Electric Utility – Generation Division, is hereby awarded to Craft Oil Corporation d/b/a PetroChoice Holdings, Avoca, PA, for the contract period of January 1, 2019 through December 31, 2019, in the amount of \$50,832.18 and the Purchasing Agent is hereby authorized and directed to issue a purchase order contract for the same on behalf of the City of Vineland; and

BE IT FURTHER RESOLVED that the Chief Financial Officer has certified that the funds for the contract to be awarded herein will be available.


