A RESOLUTION AWARDING AN OPEN-END CONTRACT

WHEREAS, the City of Vineland has heretofore advertised for bids for Traffic Control and Directional Drilling Services for the Vineland Municipal Electric Utility, for a period of one year beginning April 15, 2019 through April 14, 2020, with option to renew for one (1) additional year, in accordance with specifications on file in the office of the Purchasing Agent; and

WHEREAS, on March 12, 2019, bids were received, duly opened and read aloud, being referred to the Business Administrator for tabulation, evaluation, report and recommendation; and

WHEREAS, the Assistant Business Administrator has, under date of April 2, 2019 submitted a written report and tabulation of the bids received and has recommended that an open-end contract for Traffic Control and Directional Drilling Services for the Vineland Municipal Electric Utility, be awarded to Kline Construction Company Inc., Galloway, NJ, in the amount as follows:

Proposal A: Traffic Control Services, in the amount of \$239,633.50
Proposal B: Directional Drilling Services, in the amount of \$139,343.30
for a total award amount of \$378,976.80;

said bid being the lowest bid received and considered in the best interest of the City of Vineland; now, therefore,

BE IT RESOLVED by the Council of the City of Vineland that said contract for Traffic Control and Directional Drilling Services for the Vineland Municipal Electric Utility, for a period of one year beginning April 15, 2019 through April 14, 2020, with option to renew for one (1) additional year, be and the same is awarded to Kline Construction Company Inc., Galloway, NJ, in the amount as stated above, said bid being the lowest bid received and considered in the best interest of the City of Vineland, and the Purchasing Agent be and the same is hereby authorized and directed to issue purchase order contract for the same in behalf of the City; and

BE IT FURTHER RESOLVED that the City Comptroller has certified that the funds for the contract to be awarded herein are available.
