ORDINANCE NO. 2019-<u>55</u>

ORDINANCE AMENDING ORDINANCE 2017-72, AS AMENDED, CHAPTER 5, SECTIONS 5-11 AND 5-12 OF THE CODE OF THE CITY OF VINELAND ENTITLED DIVISION OF ENGINEERING.

WHEREAS, the Division of Engineering is a Division within the Department of Administration which has a subdivision of Planning in accordance with Ordinance 2017-72, as amended; and

WHEREAS, the functions of the Subdivision of Planning encompasses several other departments outside of the scope of the Division of Engineering; and

WHEREAS, it has been recommended by the Business Administrator, City Planner and City Engineer that the duties and responsibilities of Planning would best function as a separate division.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Vineland that Ordinance 2017-72, as amended, Chapter 5, Section 5-11 and 5-12 of the Code of the City of Vineland be amended as follows:

- 1. Section 5-11 E (1) shall be deleted in its entirety and replaced as follows:
 - E (1). Direct the operation of the Division of Engineering, manage the activities of the staff and coordinate engineering services with other divisions and departments.
- 2. Section 5-12 shall be deleted in its entirety and replaced as follows:

Section 5-12 Division of Planning

- A. The City Planner shall be the Supervisor of the Division of Planning.
- B. Functions of the Divisions. The Division of Planning shall:
 - (1.) Advise and assist the Mayor with regards to the physical planning of all matters relating to the development of the City.
 - (2.) Provide staff assistance to the Planning Board and Zoning Board of Adjustment on all matters under their jurisdiction.
 - (3.) Preform continuous studies and collect data to serve as a basis for planning recommendations to the administration.
 - (4.) Act as liaison to the South Jersey Transportation Planning Organization, County Planning Board, Landis Sewerage Authority, U.S. Bureau of the Census, and other regional, State and Federal planning organization.
 - (5.) Maintain the City of Vineland Master Plan, including the Housing Element and Fair Share Housing Plan, and the Land Use Ordinance.
 - (6.) Administer redevelopment plans.

BE IT FURTHER ORDAINED that the balance of Ordinance 2017-72, as amended, not amended hereby shall remain in full force and effect.

BE IT FURTHER ORDAINED that should any portion of this Ordinance be deemed unenforceable by a court of competent jurisdiction, that portion so determined to be unenforceable, shall be void and the balance hereof shall remain in full force and effect. **BE IT FURTHER ORDAINED** that should any Ordinance or portion thereof be inconsistent herewith, such Ordinance or portion thereof shall be void to the extent of such inconsistencies.

This Ordinance shall take effect upon adoption and publication according to law.
