

RESOLUTION NO. 2019- 397

A RESOLUTION AUTHORIZING THE ISSUANCE OF AN OPEN-ENDED CONTRACT TO SOUTH STATE MATERIALS LLC, BRIDGETON, NJ FOR SUPPLYING AND LAYING HOT MIX ASPHALT THROUGH THE CUMBERLAND COUNTY COOPERATIVE PRICING SYSTEM, IDENTIFIER #181-CCCCPS BID #19-31.

WHEREAS, the City of Vineland is a participant in the Cumberland County Cooperative Pricing System, pursuant to Resolution No. 96-534, adopted August 13, 1996; and

WHEREAS, the County of Cumberland, as the Lead Agency, has advertised for bids and received bids on behalf of all participating contracting units in the Cooperative Pricing System for Supplying and Laying Hot Mix Asphalt; and

WHEREAS, the County of Cumberland has reviewed said bids and has made an award to the lowest responsive, responsible bidder, South State Material LLC, Bridgeton, NJ, for the contract period September 1, 2019 through August 31, 2020, based on the quoted price as follows:

WHEREAS, the City of Vineland desires to enter into an agreement with South State, Inc., for Supplying and Laying Hot Mix Asphalt under the cooperative pricing system contract awarded by the County of Cumberland for the contract period September 1, 2019 through August 31, 2020, in an amount based upon the quoted price, as stated above; and

WHEREAS, the Chief Financial Officer has certified the availability of funds for the contract to be awarded herein;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF VINELAND, as follows:

THAT the Mayor and City Clerk are hereby authorized to execute an agreement with South State, Material LLC, Bridgeton, NJ for the Supplying and Laying Hot Mix Asphalt for the contract period September 1, 2019 through August 31, 2020, based upon the open-ended contract awarded by the County of Cumberland cooperative pricing system.

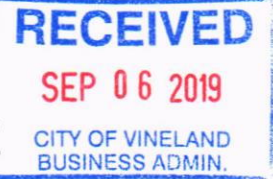
