2. The City Clerk is hereby authorized and directed to immediately return to said bidders any bid bonds, certified checks, or other forms of security submitted by such bidders.
3. The City Clerk of the City of Vineland is hereby authorized and directed to re-advertise for bids, at which time such bids submitted shall be publicly opened and read aloud.


Submitted to you herewith for your consideration is our evaluation of the proposals submitted to the Purchasing Board on November 13, 2019.
