ORDINANCE AMENDING ORDINANCE 2012-17, AS AMENDED, AN ORDINANCE AUTHORIZING AN AGREEMENT WITH UTILITY SERVICES COMPANY, INC., FERRY, GEORGIA, FOR WATER TANK MAINTENANCE AND ASSET MANAGEMENT FOR THE CITY OF VINELAND WATER UTILITY

WHEREAS, on April 24, 2012, City Council of the City of Vineland adopted Ordinance 2012-17, and Ordinance authorizing the execution of an agreement with Utility Service Company, Inc, Ferry, GA for water tank maintenance and asset managing; and

WHEREAS, on June 11, 2013 City Council adopted Ordinance 2013-21 amending ordinance 2012-17 so as to change the schedule of work for the Butler Avenue water tank and modify the buyout language and balance to be paid to reflect the adjusted work schedule; and

WHEREAS, the Director of the Vineland Municipal Utilities has requested the City Council consider the installation of a new City logo on the water tank located at Oak and Main after its complete maintenance in accordance with the contract with Utility Service Company, Inc.; and

WHEREAS, Utility Service Company has submitted a cost for installation of the City logo on said water tank in the amount of \$15,000.00 as a change order to the original water tank maintenance and asset management agreement executed in accordance with Ordinance 2012-17, as amended; and

WHEREAS, City council finds it to be in the best interest of the City to add its logo on the Oak and Main water tank as a City branding.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Vineland that the Mayor and Clerk are authorized to execute a change order to the Agreement for Water Tank Services between utility Services Company, Inc, Ferry, GA, and the City of Vineland for the Oak and Main water tank in the amount of \$15,000.00 pursuant to the proposal attached hereto and made a part hereof.

This Ordinance shall take effect upon adoption and publication according to law.
