A RESOLUTION AMENDING RESOLUTION 2019-551, A RESOLUTION AUTHORIZING A CONTRACT TO MAJOR PETROLEUM INDUSTRIES, ROSENHAYN, NJ FOR SUPPLYING AND DELIVERING GASOLINE AND DIESEL FUEL THROUGH THE CUMBERLAND COUNTY COOPERATIVE PRICING SYSTEM.

WHEREAS, on December 23, 2019, the City Council of the City of Vineland, adopted Resolution No. 2019-551, entitled, "A RESOLUTION AUTHORIZING A CONTRACT TO MAJOR PETROLEUM INDUSTRIES ROSENHAYN, NJ FOR SUPPLYING AND DELIVERING GASOLINE AND DIESEL FUEL THROUGH THE CUMERLAND COUNTY COOPERATIVE PRICING SYSTEM FOR THE PERIOD DECEMBER 1, 2019 THROUGH NOVEMBER 30, 2021; and

WHEREAS, the County of Cumberland award was to Major Petroleum Industries, Rosenhayn, NJ as adopted by Resolution 2019-693; and

WHEREAS, the County of Cumberland adopted Resolution 2019-760 at their December 17, 2019 Freeholder Meeting "Resolution Correcting Resolution 2019-693 as follows:

That additionally, Mansfield Oil Company shall be declared the winning bidder for the Cumberland County Cooperative Contract Pricing System Identifier #64-CCCPS for gasoline, 87 Octane, unleaded regular and diesel fuel (Off-Road, Dyed); Major Petroleum Industries for diesel fuel (On-Road); and

WHEREAS, the City of Vineland desires to award contracts as follows:

Mansfield Oil Co. – 87 Octane Unleaded Regular Gasoline @ \$0.1261 Delivery Charge  
Diesel Fuel (Off-Road, Dyed) @ 0.2646 Delivery Charge

Major Petroleum – Diesel Fuel (On-Road) @ \$.1365 Delivery Charge

**RESOLUTION CORRECTING RESOLUTION 2019-693, AWARDING CONTRACT FOR SUPPLYING AND DELIVERING GASOLINE AND DIESEL FUEL FOR THE COUNTY OF CUMBERLAND AND FOR PARTICIPATING MEMBERS OF THE CUMBERLAND COUNTY COOPERATIVE CONTRACT PRICING SYSTEM IDENTIFIER #64-CCCPS; BID #19-52 (RIGGINS, INC. - GASOLINE, OCTANE, UNLEADED REGULAR; MAJOR PETROLEUM INDUSTRIES - DIESEL FUEL (ON-ROAD); MANSFIELD OIL COMPANY OF GAINESVILLE, INC. - DIESEL FUEL (OFF-ROAD, DYED) (\$67,603.80 - TOTAL MAXIMUM CONTRACT AWARD)**

WHEREAS, on November 26, 2019, this Board adopted Resolution 2019-693, Awarding Contract for Supplying and Delivering Gasoline and Diesel Fuel for the County of Cumberland and For Participating Members of the Cumberland County Cooperative Contract Pricing System Identifier #64-CCCPS; and

1. That paragraph #1 of Resolution 2019-693 is hereby corrected to read as follows:

Major Petroleum Industries, Rosenhayn, NJ - Diesel Fuel (On-Road)  
Mansfield Oil Company, Gainesville, GA - Diesel Fuel (Off-Road, Dyed)

2. That paragraph #2 of Resolution 2019-693 is hereby corrected as follows:

That, additionally, Mansfield Oil Company shall be declared the winning bidder for the Cumberland County Cooperative Contract Pricing System Identifier #64-CCCPS for gasoline, 87 Octane, unleaded regular and diesel fuel (Off-Road,

Dyed); Major Petroleum Industries for diesel fuel (On-Road).

3. That in all other respects, Resolution 2019-693 remains unchanged and in full force and effect.
