A RESOLUTION AUTHORIZING THE ISSUANCE OF AN OPEN-ENDED CONTRACT TO SOUTH STATE MATERIALS LLC, BRIDGETON, NJ FOR SUPPLYING AND DELIVERING VOC-COMPLIANT HIGH PERFORMANCE COLD PATCH THROUGH THE CUMBERLAND COUNTY COOPERATIVE PRICING SYSTEM, IDENTIFIER #181-CCCCPS BID #19-30.

WHEREAS, the City of Vineland is a participant in the Cumberland County Cooperative Pricing System, pursuant to Resolution No. 96-534, adopted August 13, 1996; and

WHEREAS, the County of Cumberland, as the Lead Agency, has advertised for bids and received bids on behalf of all participating contracting units in the Cooperative Pricing System for Supplying and Delivering VOC-Compliant High Performance Cold Patch, Identifier #181-CCCCPS Bid #19-30; and

WHEREAS, the County of Cumberland has reviewed said bids and has made an award to the lowest, responsive, responsible bidder, South State Materials LLC, Bridgeton, NJ, for the contract period September 1, 2019 through August 31, 2020 based on the quoted price as follows:

WHEREAS, this Board duly received and opened bids for supplying and delivering VOC-Compliant High Performance Cold Patch for the Cumberland County Public Works Department And The Cumberland County Cooperative Contract Purchasing System Identifier #181-CCCCPS for the Cumberland County Public Works Department and the Cumberland County Cooperative Contract Purchasing System Identifier #181-CCCCPS; and

WHEREAS, bids were received as follows:

South State (2 miles x \$4.00 = \$8 x 50 round-trips = \$400.00 round-trip for County pick-up at Bridgeton Plant) plus supply/deliver equals \$78,340 total bid.

WHEREAS, the Director of Purchasing has reported that South State Materials, LLC, 202 Reeves Road, Bridgeton, NJ 08302 was the lowest responsive, responsible bidder; and

WHEREAS, the maximum contract award amount is \$156,280.00; and

WHEREAS, no amount will be encumbered until such time as good or services are ordered; and

WHEREAS, the Purchasing Agent and/or CFO/Treasurer upon approving the release of a purchase order shall ascertain that there are available sufficient uncommitted appropriations to provide payment; and

WHEREAS, the purchase order will encumber appropriate account numbers as determined by the CFO/Treasurer at the time the purchase order is created in an amount(s) not to exceed the maximum contract award of \$156,280.00 in the aggregate.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF CHOSEN FREEHOLDERS OF THE COUNTY OF CUMBERLAND, as follows:

1. That this Board hereby recommends a contract be awarded to South State Materials, LLC in accordance with the specifications and the bid of the contractor in the maximum amount of \$156,280.00 for the contract period September 1, 2019 through August 31, 2020.

2. That, additionally, South State Materials, LLC shall be declared the winning bidder for the Cumberland County Cooperative Contract Purchasing System Identifier #181-CCCCPS.

3. That the proper officers of this Board are hereby authorized and directed to execute the contract hereby awarded.
