WHEREAS, the management personnel of the Municipal Electric Utility has requested that an amendment be made to contract awarded to Rumsey Electric Co., Conshohocken, PA for furnishing and delivery of LED Street and Area Lighting for the Vineland Municipal Electric Utility – Distribution Division, as authorized by Resolution No. 2020-128; said amendment is made necessary due to the fact it was originally thought that there was an error in the technical part of the specification for Part 2.7 (Floodlight Fixtures) – Item 570-180 – 130 W LED Floodlight w/visor; and

WHEREAS, after further review and clarification, it was discovered that there were no errors; and

WHEREAS, the City of Vineland desires to comply with said requirements of N.J.A.C. 5:30-11.9, and to that end herewith files with the governing body a report stating the facts involved and indicating that said change order may be allowed under these regulations; and

WHEREAS, the Chief Financial Officer has certified the availability of funds for the amendatory supplemental change order for which authorization is requested in the estimated amount of \$54,312.50; now, therefore,

BE IT RESOLVED by the Council of the City of Vineland that said amendatory supplemental change order #1 to Contract No. C20-0059, issued to Rumsey Electric Co., Conshohocken, PA, in the estimated amount of \$54,312.50, be and the same is hereby ratified and approved.

We are requesting an amendatory supplemental change order to Contract No. C20-0059, issued to Rumsey Electric Co., Conshohocken, PA for furnishing and delivery of LED Street and Area Lighting for the Vineland Municipal Electric Utility – Distribution Division. This contract was authorized by Resolution No. 2020-128, adopted March 10, 2020, was awarded on an individual line item basis to the respective low bidders.




Figure # 3 – EXAMPLE OF 130 W FIXTURE FLOOD LIGHT (WITH VISOR)
