To this end, the Director may limit or approve adjustment of items of appropriations, by no item of appropriation required for debt service, contingent expenses, deferred charges, statutory expenditures, judgments or reserves shall be so reduced or limited.

Salary adjustments to or from contract change due to court order

Matching funds for grants such as reallocations of amount required to meet minimum match

Change in administrative code

Change from salaried individual(s) to contractual payment

## Statute does not provide for:

Substitution of a different appropriation to replace an existing appropriation

Transfer of various appropriations

Establishment of a new appropriation

To satisfy a deficiency in an appropriation
