A RESOLUTION AMENDING RESOLUTION NO. 2018-497, TO EXTEND THE PERIOD OF THE CONTRACT ISSUED TO J. BISHOP CONSTRUCTION INC., MILLVILLE, NJ FOR SNOW REMOVAL SERVICES AND ASSOCIATED EQUIPMENT.

WHEREAS, on December 11, 2018, the City Council of the City of Vineland adopted Resolution No. 2018-497, awarding an Open-End Contract to J. Bishop Construction Inc., Millville, NJ for Snow Removal Services and Associated Equipment, bid specifications providing for the option to renew for one (1) additional two (2) year term; and

WHEREAS, due to COVID-19 restrictions, it is in the best interest of the City of Vineland, that Contract 2018-497, issued to J. Bishop Construction Inc., Millville, NJ, be extended for a one (1) additional two (2) year term, beginning December 17, 2020 through December 16, 2022; and

WHEREAS, the Department of Public Works and J. Bishop Construction Inc. have agreed to extend the contract for a one (1) additional two (2) year term at the same hourly rates of the original contract;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Vineland that Resolution No. 2018-497 is hereby amended to provide for a one (1) additional two (2) year term to contract 2018-497, beginning December 17, 2020 through December 16, 2022, issued to J. Bishop Construction Inc., Millville, NJ, for Snow Removal Services and Associated Equipment, at the same hourly rates of the original contract;

BE IT FURTHER RESOLVED that the Chief Financial Officer has certified that the funds for the contract to be awarded herein are available.
