ORDINANCE NO. 2020- 58

ORDINANCE AMENDING THE CODE OF THE CITY OF VINELAND, CHAPTER 651 (TAXICABS), SECTION 5 ENTITLED FEES.

WHEREAS, it becomes necessary to calculate the cost associated with the issuance of renewals of taxicab license fees recognizing the time and effort put forth by the City; and

WHEREAS, the City Council finds it to be in the best interest of the taxpayers to increase the taxicab license fees.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Vineland that City Code, Chapter 651 entitled Taxicabs, Section 5 entitled Fees shall be deleted in its entirety and replaced as follows:

  - (for year 2022): \$112.00
  - (for year 2023): \$115.00
  - (for year 2024): \$118.00
  - (for year 2025): \$122.00
  
- B. New Owners License, Public Safety Investigation Fee, per applicant:
  - (for year 2021): \$99.00
  - (for year 2022): \$102.00
  - (for year 2023): \$105.00.
  - (for year 2024): \$108.00.
  - (for year 2025): \$111.00.
  
- C. Renewal of Owners License and Taxicab Inspection Fee, per Taxicab per year:
  - (for year 2021): \$99.00.
  - (for year 2022): \$102.00
  - (for year 2023): \$105.00.
  - (for year 2024): \$108.00.
  - (for year 2025): \$111.00
  
- D. Transfer of Owners License:
  - (for year 2021): \$109.00.
  - (for year 2022): \$112.00

- E. New Operator's License:
  - (for year 2021): \$109.00.
