A RESOLUTION AWARDING AN OPEN-END CONTRACT TO CATERINA SUPPLY INC., WILLIAMSTOWN, NJ FOR THE FURNISHING AND DELIVERY OF VALVES AND TAPPING SLEEVES FOR THE WATER UTILITY, IN THE AMOUNT OF \$60,677.69.

WHEREAS, the City of Vineland has heretofore advertised for bids for the furnishing and delivery of Valves and Tapping Sleeves for the Water Utility, for the period commencing January 1, 2021 ending December 31, 2021, with an option for a second year, in accordance with specifications on file in the office of the Purchasing Agent; and

WHEREAS, on October 27, 2020, bids were received, duly opened and read aloud, being referred to the Business Administrator for tabulation, evaluation, report and recommendation; and

WHEREAS, the Business Administrator has, under date of December 1, 2020 submitted written report and tabulation of the bids received and has recommended that an open-end contract for the furnishing and delivery of Valves & Tapping Sleeves for the Water Utility, be awarded to Caterina Supply Inc., Williamstown, NJ, in the amount of \$60,677.69, said bid being the second lowest qualified bid received and considered in the best interest of the City of Vineland; and

WHEREAS, the following bidder has been disqualified

Core & Main LP Berlin, NJ This vendor bid a product that was not compatible or equal to the product provided for in the specifications; now, therefore,

BE IT RESOLVED by the Council of the City of Vineland that said open-end contract for the furnishing and delivery of Valves and Tapping Sleeves for the Water Utility, for the period commencing January 1, 2021 ending December 31, 2021, with an option for a second year, be awarded to Caterina Supply Inc., Williamstown, NJ on their bid in the amount of \$60,677.69, said bid being the second lowest qualified bid received and considered in the best interest of the City of Vineland, and the Purchasing Agent is hereby authorized and directed to issue purchase order contract for the same on behalf of the City; and

BE IT FURTHER RESOLVED that the City Comptroller has certified that the funds for the contract to be awarded herein are available.

RE: COV 2020-29 Valves & Tapping Sleeves

I have reviewed the tabulation of bids received on October 27, 2020 for the above referenced materials.

Please be advised that it is my recommendation that the contract be awarded to the second lowest qualified bidder on the bid proposal to Caterina Supply Inc., of Williamstown NJ in the amount of \$60,677.69. For a period of one year with the option of a second year renewal.

After receiving Ford product information from Core & Main, we were able to compare the Ford items against the Mueller items in the bid proposal and found some differences, where Ford did not match items specified in the bid. Leaving us with some concerns since the Utility has always used & installed Mueller valves in the water system.

- 1. The Mueller pressure rating is rated at 350 psi vs. 250 psi of the Kennedy Valve.
- 2. Mueller includes a 4<sup>th</sup> seal that Kennedy does not have, the Mueller 4<sup>th</sup> seal prevents infiltration of the stuffing box.
- 3. Mueller uses a forged bronze stem which is dense, Kennedy uses a cast bronze stem.
- 4. Mueller valves include caps on the wedge guides, which protect the rubber on the guides from wear, prolonging life. The Kennedy submittal did not show this on their valve.
- 5. Mueller valves have integrated lifting lugs on the stuffing box, also the lugs serve for valve box alignment. The Kennedy valve does not show this feature.
- 6. The Kennedy valve parts are not interchangeable with the Mueller valves and parts currently kept in the Utility warehouse. Mueller valves have been installed throughout the water system & water treatment plants.

The butterfly valve currently used has a seat on body design vs the seat on disc design that Core & main submitted. The seat on disc design is preferred for installation in treatment plants.
