

ORDINANCE NO. 2021- 2

AN ORDINANCE ESTABLISHING AND REVISING THE SPEED LIMIT FOR CERTAIN PORTIONS OF LANDIS AVENUE IN THE CITY OF VINELAND.

WHEREAS, the speed limit for certain portions of Landis Avenue has been recommended by the City of Vineland Engineer; and

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Vineland, as follows:

SECTION 1. The speed limit for both directions of traffic along the following street is hereby established as follows:

LANDIS AVENUE		
Zone	Speed Limit (MPH)	Location
1	50	Between the Pittsgrove Township, Salem County/Vineland City, Cumberland County corporate line to 1,600 feet east of the Pittsgrove Township, Salem County/Vineland City, Cumberland County corporate line
2	45	Between 1,600 feet east of the Pittsgrove Township, Salem County/Vineland City, Cumberland County corporate line to N.J. Route 47
3	35	Between N.J. Route 47 (Delsea Drive) to West Avenue
4	25	Between West Avenue and Myrtle Street
5	35	Between Myrtle Street and Main Road

SECTION 2. Regulatory and warning signs shall be erected and maintained to effect the above-designated speed limit as authorized by the Department of Transportation.

SECTION 3. All ordinances or parts thereof inconsistent with the provisions of this ordinance are hereby repealed to the extent of such inconsistency.

SECTION 4. This Ordinance shall take effect upon publication and passage in the manner provided by law and upon approval by the Commissioner of Transportation of the State of New Jersey.

The City of Vineland has a situation where Landis Avenue has varying speed limits and there is only an Ordinance for two sections between Pittsgrove Township and Delsea Drive. Based on legal existing speed limits, existing speed limit signage, and understanding of statutory speed limit definitions, I recommend that the following speed limits be affirmed by Ordinance:

Zone	Speed Limit (MPH)	Location
1	50	Between the Pittsgrove Township, Salem County/Vineland City, Cumberland County corporate line to 1,600 feet east of the Pittsgrove Township, Salem County/Vineland City, Cumberland County corporate line
2	45	Between 1,600 feet east of the Pittsgrove Township, Salem County/Vineland City, Cumberland County corporate line to N.J. Route 47
3	35	Between NJ Route 47 (Delsea Drive) to West Avenue
4	25	Between West Avenue and Myrtle Street
5	35	Between Myrtle Street and Main Road
