Education: Public awareness about pedestrian safety must be raised. Programs should target the entire community, with a special emphasis on children, senior citizens, and non-English speaking residents.

Engineering: High-risk pedestrian intersections should be improved as much as possible with enhanced crosswalk markings and signage.

Enforcement: Motorists who commit moving violations that put pedestrians at risk should be target for summonses. In addition, Pedestrians whose own actions put them at risk should also be issued summonses and/or warnings.

Vineland is a city of approximately 65,000 residents, spread out over 69 square miles. Daytime population increases are consistent with worker commuter travel. Vineland includes large retail spaces, and industrial complex, and numerous agricultural areas. The increased traffic from these area creates a potential hazardous situation for our pedestrians and bicyclists. The Vineland Police Traffic Safety Unit receives a high volume of complaints from the community pertaining to speeding, running red lights, inattentive drivers using cell phone devices and not yielding for pedestrians.

Some of the most common dangerous characteristics within the City of Vineland are crashprone intersections, which are receiving high traffic volumes. Vineland is one of the most dangerous places for people to travel on foot as well. Many parents don't allow their children to walk to school, or even to school bus stops, because they feel the streets are not safe for pedestrians. This adds to the vehicle traffic at rush hour periods. Drivers are not yielding for pedestrians and not enough crossing guards are posted. Many streets have insufficient crosswalks, sidewalks, lighting and signals, curbs and barriers. Additionally, pedestrians are illegally crossing the roadway due to the influence of alcohol or drugs outside, as well as, within the crosswalk. Patrol enforcement has been working on the problem for the past three years, and 19,290 motor vehicle stops have been made. However, as shown in the table below, the problem has only slightly improved.

The City of Vineland has conducted a Pedestrian Enforcement grant for the last two years, and as the stats above indicate, we are beginning to see improvement in the number of pedestrians injured, total crashes, and total fatal crashes in our jurisdiction. Our dedicated Traffic Safety Unit, has worked tirelessly to address the issues of traffic safety with consistency. Continuing our public education and enforcement campaign is timely and vital to Vineland. Securing this grant funding, and incorporating it annually, would continue to impact our efforts to improve pedestrian safety.
