

ORDINANCE NO. 2021- 34

AN ORDINANCE AMENDING ORDINANCE NO. 2002-29 PROVIDING FOR NO PARKING RESTRICTIONS.

WHEREAS, the City Council of the City of Vineland on June 11, 2002, adopted Ordinance No. 2002-29, An Ordinance Providing for No Parking Restrictions along Pine Avenue, Hickory Place, Castpa Place, and North Mill Road; and

WHEREAS, the City Engineer has received concerns regarding vehicles parking along side of the road on Pine Avenue preventing the City’s effort to clean up portions of Pine Avenue; and

WHEREAS, the City Engineer has reviewed the site and is recommending the repeal of the ordinance as it relates to Pine Avenue; and

WHEREAS, the City Engineer has determined that it is in the best interest of the City to amend Ordinance No. 2002-29 to remove the “No Parking Certain Hours along Pine Avenue” section only and establish a “No Parking Anytime” restriction; and

WHEREAS, the Vineland Police Department and the City Solicitor concur with the City Engineer’s recommendation; and

WHEREAS, the City Council of the City of Vineland finds it to be in the best interest of the City to amend Ordinance No. 2002-29 in accordance with the recommendations of the City Engineer;

NOW, THEREFORE, be it Ordained by the City Council of the City of Vineland as follows:

SECTION 1: Ordinance No. 2002-29 shall be amended to repeal the Pine Avenue “No Parking Certain Hours” restriction.

SECTION 2: A “No Parking Anytime” restriction shall be established for:

<u>Name of Street</u>	<u>Side</u>	<u>Location</u>
Pine Avenue	Both	Entire Length

SECTION 3: Signs shall be erected and maintained as authorized by the Commissioner of Transportation of the State of New Jersey.

SECTION 4: All other ordinances or parts of ordinances inconsistent with the provisions of this ordinance are hereby repealed to the extent of such inconsistency.

SECTION 5: This Ordinance shall take effect upon passage and publication as provided by law and upon approval by the Commissioner of Transportation of the State of New Jersey.

SECTION 6: Any person who violates this Ordinance shall be subject to fines and penalties as set forth in the Code of the City of Vineland at §442-25(A).

I have received concerns regarding vehicles parking on Pine Avenue. Parks and Grounds have been unable to clean up portions due to vehicles parking along side of the road. Currently, there is an existing Ordinance §2002-29 for this location as no parking overnight (No Parking between 9:00 PM and 7:00 AM). After the Engineering Department reviewed the site, the recommendation is to repeal the Ordinance as it relates to Pine Avenue. Please repeal the Ordinance to no longer establish No Parking Certain Hours along Pine Avenue. Please also prepare an Ordinance establishing No Parking along Pine Avenue as follows:
