NOW, THEREFORE BE IT RESOLVED, by the Council of the City of Vineland that Resolution No. 2020-472 is hereby amended to change the period to July 19, 2021 through July 18, 2023, with an option to renew for (2) one-year terms or (1) two-year term, at a fee of 15% of the collected amount.
