ORDINANCE NO. 2021- 58

ORDINANCE AMENDING ORDINANCE 2006-14, AS AMENDED, CHAPTER 135, SECTION 135-9 OF THE CODE OF THE CITY OF VINELAND DELETING RECREATION AS A SUBDIVISION OF PUBLIC WORKS AND AMENDING ORDINANCE 1062, AS AMENDED, CHAPTER 5 OF THE CODE OF THE CITY OF VINELAND, ENTITLED ADMINISTRATION ESTABLISHING THE DIVISION OF RECREATION THEREIN.

WHEREAS, Chapter 135 of the Code of the City of Vineland entitled Department of Public Works, maintained therein, in Section 135-9, the Subsection of Recreation; and

WHEREAS, the Business Administration recommended that the Subdivision of Recreation, including the rental and reservation of the City Parks and Athletic Fields would best be monitored and operated under the authority of the Business Administration as the Department of Public Works has many duties and responsibilities and it would be in the best interest of the City, and its several Departments; and

WHEREAS, City Council finds it to be in the best interest of the efficiency of the City to move Recreation into the Department of Administration

NOW, THEREFORE, BE IT RESOLVED that Ordinance 97-87, as amended, Chapter 135 Section 135-9 and Ordinance 1062, as amended, Chapter 5 of the Code of the City of Vineland be amended as follows.

1. Chapter 135, Section 135-9 be and is hereby deleted in its entirety.
2. Chapter 5 of the Code of the City of Vineland is hereby amended by the addition of the following:

Section 5-16 Division of Recreation

- A. The Division of Recreation shall be established within the Department of Administration.
- B. Functions of the Division. Under the direct supervision of the Superintendent of Recreation and under the general supervision of the Business Administrator, the Division shall, subject to the policies and rules of the Recreation Commission:
 - (1.) Plan, promote, organize and administer comprehensive recreation programs and services for the community.
 - (2.) Schedule the use of park and recreation facilities in coordination with the Recreation Commission, collect all fees and costs associated with the same, and provide appropriate accounting thereof, and enforce the provisions and regulations of the City applicable thereto.
 - (3.) Repair, maintain, construct, and reconstruct all municipal athletic fields and courts and equipment associated therewith including those upon which the City is the operator, all municipal swimming pools and swimming areas including natural swimming areas.
 - (4.) Prepare all necessary budgets, grant and loan applications and reports regarding all fields, courts and swimming pools and areas.
 - (5.) Enforce all rules and regulations of Chapter 507 of the Code of the City of Vineland as applicable to the Division of Recreation.

BE IT FURTHER ORDAINED that the balance of Ordinance 97-87 and Ordinance 1062, as both may be amended, not amended hereby shall remain in full force and effect.

BE IT FURETHER RESOLVED that any Ordinance or portion thereof inconsistent herewith shall be void to the extent of such inconsistency.
