

RESOLUTION NO. 2021 - 513

A RESOLUTION AUTHORIZING A CONTRACT TO FURNISH & INSTALL A PERIMETER FENCE & SLIDE GATES AT 1045 BUTLER AVENUE AND REMOVE & REPLACE TENNIS COURT FENCE AT GITTONE PARK WITH GUARDIAN FENCE COMPANY, INC., NEWARK, NJ, PURSUANT TO A COUNTY COOPERATIVE CONTRACT AGREEMENT WITH HUNTERDON COUNTY EDUCATIONAL SERVICES COMMISSION COOPERATIVE PRICING SYSTEM.

WHEREAS, there is a need for a perimeter fence & slide gate at 1045 Butler Avenue and remove & replace tennis court fence at Gittone Park; and

WHEREAS, the City of Vineland is a member of a County Cooperative Purchasing Agreement known as the Hunterdon County Educational Services Commission Cooperative Pricing System under member number #34HUNCCP and, Hunterdon County ESC is a county cooperative contract organization; and

WHEREAS, Hunterdon County ESC, County Cooperative Purchasing Program has acted as lead agency and awarded Contract #HCESC-Cat/Ser-19-16, Fencing, Repair & Replacement. Specific information regarding the contract may be found on the Hunterdon County ESC website at <http://purchasing.hcesc.com>; and

WHEREAS, N.J.S.A. 52:34-6.2 permits the City of Vineland to enter into a contract to furnish and install a perimeter fence & slide gate at 1045 Butler Avenue and remove & replace tennis court fence at Gittone Park using the offered County Cooperative Contract without public bidding, subject to the submittal and acceptance of certain documentation by Guardian Fence Company, Inc., Newark, NJ;

WHEREAS, the City of Vineland intends under Hunterdon County ESC, under the Category: Fencing, Repair & Replacement, Contract #HCESC-Cat/Ser-19-16, to purchase the following from Guardian Fence Company, Inc., Newark, NJ:

1. Furnish and install a perimeter fence & slide gate at 1045 Butler Avenue - \$63,840.00
2. Remove & replace tennis court fence at Gittone Park - \$66,490.00,

as listed in the Quotations, dated September 7, and July 8, 2021, made available through the Hunterdon County ESC.

WHEREAS the Business Administrator and the Qualified Purchasing Agent, with the concurrence of the Business Administrator, recommend the use of the County Cooperative Pricing through Hunterdon County ESC for this procurement;

WHEREAS, the City of Vineland Purchasing Agent has determined that the use of the offered County Cooperative Contract will result in cost savings after all factors, including charges for service, material and delivery have been considered and has verified that such equipment is not available through State Contract awarded by the Division of Purchase and Property in the New Jersey Department of the Treasury pursuant to N.J.S.A. 40A:11-12; and

WHEREAS, the availability of funds for said purchase to be awarded herein have been certified by the Chief Financial Officer; and

WHEREAS, the City of Vineland has certified that this meets the statute and regulations governing the award of said contracts;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF VINELAND, that the Purchasing Agent is authorized to prepare purchase orders for the above items and services, for an aggregate price not to exceed \$130,330.00.

BE IT FURTHER RESOLVED that the purchase order shall contain a requirement that “the vendor shall maintain all documentation related to products, transactions or services under this contract for a period of five years from the date of final payment. Such records shall be made available to the New Jersey Office of the State Comptroller upon request”.

- 3) Furnish and install approximately 90 LF of top lock slats.
