In order to remove the high deductible plan, Dina from Allen Associates informed me we would need to pass/approve the attached Resolution. The plan we need to remove is NJ Direct HD 1500 Plan. This is the plan that requires an employer funded \$300 Health Savings Account. The NJ Direct HD 4000 Plan allows for a Health Savings Plan but it is <u>not</u> employer funded. Also, per the attached Resolution we are required to offer at least one plan from each category. The category in question is Category 5.
