1. That this Board hereby recommends a contract be awarded to W.B. Mason Company, Inc., in accordance with the specifications and the bid of the contractor in the maximum amount of $\$ 72,400.00$ for the contract period of January 1, 2022 through to December 31,2023 . The County shall have the option to renew the contract for one (1) additional one (1) year term and all terms and conditions of the original contract including discount amounts, shall remain in force.
2. That, additionally, W.B. Mason Company, Inc. shall be declared the winning bidder for the Cumberland County Cooperative contract Purchasing System identifier \#181CCCCPS.
3. That the proper officers of this Board are hereby authorized and directed to execute the contract hereby awarded.
4. The contract shall be contingent upon appropriation of sufficient funds by the Board of County Commissioners in the 2022 and 2023 temporary and/or permanent budgets.
