Whereas, the purchase order will encumber appropriate account numbers as determined by the CFO/Treasurer at the time the purchase order is created in an amount(s) not to exceed the maximum contract award of \$150,344.49 in the aggregate.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUJNTY COMMISSIONERS OF THE COUNTY OF CUMBERLAND, as follows:

1. That this Board hereby recommends a contract be awarded to WB Mason Company in accordance with the specifications and the bid of the contractor in the amount of \$150,344.49 for the contract period February 1, 2022, through to January 31, 2024. The County has the option to renew the contract for two (2) additional one (1) year term.

2. That the proper officers of this Board are hereby authorized and directed to execute the contract hereby awarded.

3. That said contract shall be contingent upon appropriation of sufficient funds by the Board of County Commissioners in the temporary and/or permanent 2022, 2023 and 2024 budgets.
