Attached is the Owner application and letter request of transfer of ownership between Vasquez and Alberto.

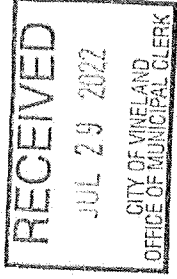
Kindly provide me written notice as soon as possible regarding the Chief's recommendations and decision on this matter.

The Applicant affirms that he or she has adequately provided for the safety of children under the age of five (5) years who are passengers in a taxicab operated by him or her. The applicant further affirms that there is a written policy and notice posted at the base of operation and in each taxicab operated by him or her, conspicuous to drivers, setting forth that, prior to the operation of the taxicab, children eighteen (18) months of age or younger who are passengers in a taxicab shall be placed in a federally approved child restraint seat and that children over the age of eighteen (18) months but under the age of five (5) years must be placed in a car seat if riding in the front seat of a taxicab or in a lap and/or lap and shoulder harness seat belt if riding in the rear seat of a taxicab.

By affixing my signature below, I affirm the following license conditions are true and I certify that this application contains no willful misstatement of fact or omission of material fact and I am aware that if any of the statements made by me are willfully false, I am subject to license revocation and subject to any other penalties, fines and disciplinary action provided by law.

Note: Upon filing this application with the City Clerk, it will be forwarded for investigation by the City of Vineland Police Department. After the City Clerk receives a written report from the Police, the application will be considered by City Council for approval or denial, if an owner's license is available. In the event a license is not available, the application will be kept on file as directed according to prevailing ordinance provisions.

All applicants must provide a copy of the insurance policy of a company duly licensed to transact business under the insurance laws of the State of New Jersey, conditioned for the payment of a sum of not less than \$15,000.00 to satisfy all claims for damages by reason of bodily injury to, or the death of, any one person resulting from an accident, and a sum of not less than \$30,000.00 to satisfy all claims for damages, by reason of the bodily injuries to, or the death of, all persons on account of any such accident by reason of the ownership, operation, maintenance or use of such taxicab upon any public street; and conditioned for the payment of a sum not less than \$5,000.00 to satisfy any claim for damages to property of any one person resulting from an accident and a sum not less than \$5,000.00 to satisfy all claims for damages to property of all persons on account of any such accident by reason of the ownership, operation, maintenance or use of such taxicab upon any public street.

Power of Attorney... Pursuant to N.J.S.A. 16-5, every owner shall execute and deliver to the City Clerk concurrently with the filing of the insurance policy or bond, a power of attorney, wherein and whereby the owner shall appoint the City of Vineland chief fiscal officer his/her true and lawful attorney for the purpose of acknowledging service of any process out of a court of competent jurisdiction to be served against the insured by virtue of the indemnity granted under the insurance policy or bond filed.
