

Comments: All bidders submitted all the mandatory documents.

NOTE: My award evaluation was based on estimated hourly rates based on prior year spent for said services. I put most of the emphasis on the Regular Hours as previous year's work was done during regular time.

Recommendation: Based on the attached, I recommend awarding to Northeast Electrical Services LLC as the evaluation shows they are the lowest responsive responsible bidder. The evaluation is only an estimate and does not include costs for parts and equipment so the department will need to determine the estimated amount of award for this contract. Based on previous year spend an estimated amount not to exceed cost should be \$30,000 (labor plus estimated \$15,000 for parts & equipment) per year but that depends on the Water Department's budget.
