WHEREAS, the City of Vineland has certified that this meets the statute and regulations governing the award of said contracts.

- 1. The Purchasing Agent be and the same is hereby authorized to issue contract to Atlantic Coast Alarm, Mayslanding, NJ for Video Surveillance for the Vineland Library, in an amount not to exceed \$84,500.00.
- 2. That the Business Disclosure Entity Certification, the Political Contribution Disclosure Form and the Determination of Value be placed on file with the Resolution.
