#### RESOLUTION NO. 2022-450

A RESOLUTION AUTHORIZING A CONTRACT WITH UGI ENERGY SERVICES, WYOMISSING, PA FOR NATURAL GAS SUPPLY SERVICES, PURSUANT TO A COUNTY COOPERATIVE CONTRACT AGREEMENT THROUGH THE LEAD AGENCY, COUNTY OF CAMDEN.

WHEREAS, the City of Vineland is in need of Natural Gas Supply Services; and

WHEREAS, the City of Vineland is a member of the South Jersey Power Cooperative; and

WHEREAS, County of Camden, as lead agency of the South Jersey Power Cooperative has awarded a contract, under a fair and open process (BID A-44/2022), for Natural Gas Supply Services; and

WHEREAS, N.J.S.A. 52:34-6.2 permits the City of Vineland to procure Natural Gas Supply Services using the offered County Cooperative Contract without public bidding, subject to the submittal and acceptance of certain documentation by UGI Energy Services; and

WHEREAS, the City of Vineland intends through the County of Camden to award a contract to UGI Energy Services, Wyomissing, PA for Natural Gas Supply Services for the contract period of thirty-six (36) months beginning December 1, 2022 to November 30, 2025, at the dekatherm price of \$12.334/dth

WHEREAS the Qualified Purchasing Agent, with the concurrence of the Business Administrator, recommend the use of the County Cooperative Pricing through South Jersey Power Cooperative, County of Camden for this procurement;

WHEREAS, the City of Vineland Purchasing Agent has determined that the use of the offered County Cooperative Contract will result in cost savings after all factors, including charges for service, material and delivery have been considered and has verified that such services is not available through State Contract awarded by the Division of Purchase and Property in the New Jersey Department of the Treasury pursuant to N.J.S.A. 40A:11-12; and

WHEREAS, the availability of funds for said purchase to be awarded herein have been certified by the Chief Financial Officer; and

WHEREAS, the City of Vineland has certified that this meets the statute and regulations governing the award of said contracts;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF VINELAND, that the Purchasing Agent is authorized to prepare a purchase order for Natural Gas Supply Services for the contract period of thirty-six (36) months beginning December 1, 2022 to November 30, 2025, at the dekatherm price of \$12.334/dth.

BE IT FURTHER RESOLVED that the purchase order shall contain a requirement that
"the vendor shall maintain all documentation related to products, transactions or services under
this contract for a period of five years from the date of final payment. Such records shall be
