Description of Project

Execution of this project will allow for increased transparency within the electric and water distribution systems while offering customers the ability to see granular data on their usage, offering better insight into their bill as well as usage patterns, all while lowering Utility costs. This project includes the back-end infrastructure, customer portal integration, pay-as-you-go options, as well as a Phase 1 pilot equipment (meters, interface units, portable devices, etc.) to fully evaluate the system performance, features, and customer experience prior to an anticipated (Phase 2) multi-year rollout throughout the City.

* - Increases in quantities were made to these items due to current supply chain constraints leading to longer than nominal lead times. This allows the Utility to insert a placeholder with the Vendor for the quantity of meters and MIUs listed above to allow for practically no lead time issues when Phase 1 is complete, transferring financial risk to the Vendor while also providing an overall cost savings of approximately \$68,000 due to defined inflationary pricing costs.

By awarding the items listed above we will be appropriating the full system infrastructure, required head-end and portable devices for system commissioning, as well as an increased quantity of meters and MIUs which will allow for the Utility to lower overall rollout costs and timeline by reducing supplier lead time risk.
