A RESOLUTION AUTHORIZING THE EXECUTION OF A PROFESSIONAL SERVICES AGREEMENT BY AND BETWEEN THE CITY OF VINELAND AND LEE TOFANELLI AND ASSOCIATES, LANDIS AVENUE VINELAND, NJ FOR MARKETING, ADVERTISING, PROMOTIONAL & PUBLIC RELATIONS/CONSTITUENT CONSULTING SERVICES.

WHEREAS, City Council finds it in the best interest of the residents of the City of Vineland to properly and fully advise the residents of issues facing the City and further recognizes that a properly informed public is an invaluable tool for the efficient administration of local government and that an avenue of information must exist to notify local news media of events affecting the residents; and

WHEREAS, the City of Vineland has heretofore advertised for proposals for Professional Services for marketing, advertising, promotional & public relations/constituent consulting services; and

WHEREAS, the Requests were published in the City of Vineland's official newspaper and official website; and

WHEREAS, one proposal was received and referred to the City Solicitor for evaluation and recommendation; and

WHEREAS, it has been recommended that a contract for the required services be awarded to Lee Tofanelli & Associates, Landis Avenue, Vineland, New Jersey based upon the proposal received, pursuant to a fair and open process; and

WHEREAS this contract is awarded in an amount not to exceed \$111,600.00 per annum for services specified in Scope of Services outlined in the Request for Proposals/Qualifications including website maintenance and hosting services and management of all social media accounts and shall invoice additional media at cost plus a commissionable rate of 15% for all such further related services upon submission of proposals per requested project for a contract period beginning February 1, 2023 through January 31, 2024, with option to renew for three (3) additional one (1) year terms; and

WHEREAS, the availability of funds for said Professional Services Contract to be awarded herein have been certified by the Chief Financial Officer; and

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Vineland that said contract for Professional Services for marketing, advertising, promotional & public relations/constituent consulting services be awarded to Lee Tofanelli and Associates, Landis Avenue, Vineland, New Jersey, based upon the proposal received, pursuant to a fair and open process, in the amount not to exceed \$111,600.00 for marketing, advertising, promotional & public relations/constituent consulting services for a contract period beginning February 1, 2023 through January 31, 2024, with option to renew for three (3) additional one (1) year terms.

# PROPOSAL COST AND STATEMENTS OF FACT

Based on the Scope of Services outlined in this Request For Proposal, Lee Tofanelli and Associates, Inc. would propose a monthly retainer of \$6,850.00, which would encompass all of the requested services outlined in the RFP.
