RESOLUTION AUTHORIZING THE CITY OF VINELAND TO ACCEPT A GRANT AWARD UNDER THE FFY22 HMEP PLANNING AND TRAINING GRANT MADE AVAILABLE THROUGH THE NEW JERSEY DEPARTMENT OF LAW AND PUBLIC SAFETY, OFFICE OF ATTORNEY GENERAL.
