NOW, THEREFORE BE IT RESOLVED, by the Council of the City of Vineland that the Purchasing Agent is hereby authorized to issue an extension to Contract No. C22-0083, issued to County Conservation Co., LLC., Sewell, NJ for the Grinding and Hauling of Brush at Material Handling Facility for the Department of Public Works, in the estimated total amount of \$22,640.00 for the option year beginning January 1, 2023 to December 31, 2023, at the same terms and conditions.
