A RESOLUTION AUTHORIZING AWARD OF A CONTRACT TO STARNET SOLUTIONS, INC., FARMINGDALE, NJ, FOR THE ARCSERVE APPLIANCE 9504DR ANNUAL MAINTENANCE RENEWAL, IN AN AMOUNT NOT TO EXCEED \$109,995.60.

WHEREAS, the City of Vineland wishes to renew the annual maintenance contract for the Arcserve Appliance 9504DR; and

WHEREAS, the City of Vineland has a need to acquire such service as a Non-Fair and Open Contract pursuant to N.J.S.A. 19:44A-20.5; and

WHEREAS, the purchasing agent has determined and certified in writing that the value of said services will exceed \$17,500.00; and

WHEREAS, the Municipal Director of Information Systems has recommended that a contract be awarded to Starnet Solutions, Inc., Farmingdale, NJ, in an amount not to exceed \$109,995.60, for the contract period beginning July 1, 2023 through June 30, 2024; and

WHEREAS, Starnet Solutions has completed and submitted a Business Entity Disclosure Certification for Non-Fair and Open Contract which certifies that Starnet Solutions has not made any reportable contributions to a political or candidate committee in the City of Vineland in the previous one year and that the contract will prohibit Starnet Solutions from making any reportable contributions through the term of the contract to a political or candidate committee in the City of Vineland; and

WHEREAS, the availability of funds for said contract to be awarded herein have been certified by the Chief Financial Officer; and

WHEREAS, the City of Vineland has certified that this meets the statute and regulations governing the award of said contracts.

NOW THEREFORE BE IT RESOLVED, by the Council of the City of Vineland that:

1. The Purchasing Agent be and the same is hereby authorized to issue contract to Starnet Solutions, Inc., Farmingdale, NJ for the Arcserve Appliance 9504DR Annual Maintenance Renewal, in an amount not to exceed \$109,995.60, for the contract period beginning July 1, 2023 through June 30, 2024.
2. That the Business Disclosure Entity Certification, the Political Contribution Disclosure Form and the Determination of Value be placed on file with the Resolution.
3. Notice of this action shall be printed once in the Daily Journal.

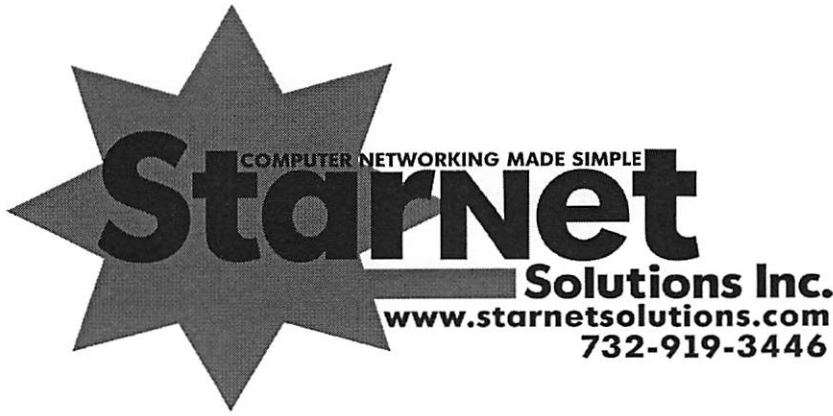
