- 2. That the City of Vineland shall accept the award of grant funding in the corrected total amount of \$174,173.00 for participation in the 2023 Safe and Secure Community Grant Program.

2nd – Your resolution – it notes that this is FEDERAL funding – it is actually STATE funding. That needs to be changed to STATE

Make sure once you correct the budget – you change the amount of the total project /fringe.

3rd – your application authorization form – page 1 needs the total project cost – not the grant amount only.
