RESOLUTION EXERCISING OPTION TO EXTEND
CONTRACT NO. C22-0123 FOR OPEN-END CONTRACT

WHEREAS, on September 13, 2022, City Council adopted Resolution No. 2022-377, awarding an open-end contract to South State, Inc., Bridgeton, NJ for the Supplying and Laying Hot Mix Asphalt for the contract period September 1, 2022 through August 31, 2023, with option to renew for one (1) additional one (1) year term, based upon the open-ended contract awarded by the County of Cumberland cooperative pricing system; and
