

RESOLUTION NO. 2023-335

A RESOLUTION AUTHORIZING THE USAGE OF CONTRACTS WITH HUNTERDON COUNTY EDUCATIONAL SERVICES COMMISSION COOPERATIVE PRICING SYSTEM VENDORS FOR THE 2023 CALENDAR YEAR.

WHEREAS, the City of Vineland is a member of the Hunterdon County Educational Services Commission Cooperative Pricing System (#34-HUNCCP), pursuant to N.J.S.A. 40A:10, 11& N.J.A.C. 5:34-7.3, 7.4, 7.12 and Resolution No. 2018-90 adopted on February 27, 2018 by the City of Vineland's City Council; and

WHEREAS, the City of Vineland has the need, on a timely basis, to purchase goods or services by utilizing the Hunterdon County Educational Services Commission Cooperative Pricing System Contracts & Vendors; and

WHEREAS, the City of Vineland may enter into contractual agreements with the Hunterdon County Educational Services Commission Cooperative Pricing System Vendors through this resolution and properly executed contracts/purchase orders, which shall be subject to all the conditions applicable to the current New Jersey Local Public State Contracts Law; and

NOW THEREFORE, BE IT RESOLVED, that the City Council of the City of Vineland, New Jersey authorizes the City Purchasing Agent to purchase certain goods or services from the approved Hunterdon County Educational Services Commission Cooperative Pricing System (#34-HUNCCP), pursuant to all conditions of the Hunterdon County Educational Services Commission Cooperative Pricing System individual Contracts; and

BE IT FURTHER RESOLVED, that the Hunterdon County Educational Services Commission Cooperative Pricing System (#34-HUNCCP) Contract vendors and their corresponding numbers may change during the timeframe indicated below and that the City Purchasing Agent is hereby authorized to make the necessary adjustments to the vendor list as may be required for the City to continue its routine procurement practices throughout the indicated timeframe; and

BE IT FURTHER RESOLVED, that the City Council of the City of Vineland, pursuant to N.J.A.C. 5:30-5.5(b), the certification of available funds and that no contract amount shall be chargeable or certified until such times as the goods or services are ordered or otherwise called for prior to placing the order and a certification of availability of funds shall be made by the City's Chief Financial Officer; and

BE IT FURTHER RESOLVED that the duration of the contracts between the City of Vineland and the Hunterdon County Educational Services Commission Cooperative Pricing System (#34-HUNCCP) Contract Vendors shall be for the period of July 11, 2023 through December 31, 2023 or until the expiration of the referenced vendors' Hunterdon County Educational Services Commission Cooperative Pricing System (#34-HUNCCP) Contract, whichever shall occur first.
